ECO-FRIENDLY SNAIL AND SLUG BAIT

A BAIT FORMULATION FOR THE CONTROL OF SNAILS AND SLUGS.

ACTIVE INGREDIENT: Iron (Fe) 9.75 g/kg

PRECAUTIONS:

- Do not swallow EcoBait.
- Keep out of reach of children, uninformed persons, and animals.
- Store away from food and feeds.
- Do not eat, drink, or smoke whilst applying.
- Wash hands with soap and water after handling this product.
- Prevent contamination of food, feed, drinking water, and eating utensils.
- For good occupational hygiene, wear gloves during mixing/loading activities and when applying by hand.
- May cause eye irritation. Avoid contact with eyes.
- Empty container completely before disposal.
- Destroy the empty container. Do not re-use the container for any other purpose.

DIRECTIONS FOR USE: Use as directed.

Application:

Scatter the pellets on the soil, around or close to the plants you would like to protect against snails.

Scatter evenly and do not heap the pellets.

Apply onto moist soil, with no standing water.

Re-application is required every three weeks or as the bait is consumed by snails or slugs.

More regular application will be required in areas that get heavily watered or after experiencing long periods of rain.

Snails and slugs are most active during the night or early mornings. Apply EcoBait pellets in the evening or late afternoon for best results.

1 kg of ECOBAIT pellets will cover 1000 m².

RESIDUES:

Because the active ingredient is a compound found naturally in the soil, and the percentage of active ingredient applied in these crops is far less than the limited daily dietary intake. The Department of Health indicated that is no need for an MRL.
