MAKHROROOT No. 2 is a Hormone Powder to be used on semi-hardwood cuttings to stimulate fast and prolific rootings.

NOTES:

- As soon as the plant-cutting is dipped in the powder, the auxin is absorbed, resulting in the rapid stimulation of root-forming.
- Over stimulation may injure the cutting, as where under stimulation may not give satisfactory result.
- Lateral shoots of the current year's growth are the best. Each specie however determines its own method of propagation. The cutting must preferably be cut at a node and cleaned from lower leaves. Moisten the lower part of the cutting and dip the bottom 10-15 mm in the powder. Shake off excess powder and plant the cutting in the right medium.

MAKHROROOT Nr. 2 is 'n hormoonpoeier wat op semi-hardehoutsteggies gebruik word om vinnige en produktiewe wortels te stimuleer.

NOTAS:

- Sodra die plant steggie in die poeier gedoop word, word die auxien geabsorbeer, wat die vinnige stimulerings van wortel-vorming tot gevolg het.
- Oor-stimulasie kan die steggie beseer, waar onder-stimulasie nie bevredigende resultate kan gee nie.
- Laterale lote van die huidige jaar se groei is die beste. Elke spesie bepaal egter sy eie metode van voortplanting. Die steggie moet verkieslik by 'n knoop gesny word en van laer blare skoongemaak word. Vog die onderste gedeelte van die steggie en doop die bodem 10-15 mm in die poeier. Skud oortollige poeier af en plant die steggie in die regte medium.

VRYWARING

Inslikking: Was mond met water. Gee 2-4 koppies melk. Hou pasiënt rustig. Indien nodig, kry mediese hulp.

Vel: Verwyder besoedelde klere. Was met seep en water. Indien nodig, kry mediese hulp.

Advies aan dokter: Nie-spesifieke teenmiddel bekend, simptoomb- en ondersteuningsbehandeling. Gee opsomming van simptome / produkinnligting aan die dokter.
