

DIRECTIONS FOR USE:

Flowers: Mix 5 ml (1 tsp) per 5 l water and spray.
Fruit Trees: 25 ml (1 level measuring cup) per tree.
(Measuring cup provided)

Why plants need potassium: Potassium Sulfate (SOP) contains sulfur, which plays a variety of key roles in optimal growth and development, and when delivered in the sulfate form, it is readily available for plant uptake. Potassium improves a plant's water use, through the regulation of photosynthesis and transpiration.

Identify potassium deficiency: Curled leaf tips, not where the whole leaf is curled up, just the tips. Usually on that same leaf, you will notice yellow edges. The yellowing will later consume the whole leaf and eventually start to turn brown. Another sign of potassium deficiency is Chlorosis, yellowing between the veins of the leaf or purple spotting on the underside of the leaf. (Look for these problems starting in the bottom of the plant and then slowly working its way up.)

Wear eye protection/face protection.
IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER/doctor.
